Registration Fee and Deposit (Not applicable for funded only places)

- Registration Fee payable on applying for a place £200
- Deposit payable on the acceptance of a place £600

Important Notes

- **Sessions:** The Nest operates with a **minimum requirement of three sessions per week**. Parents may choose to do either morning sessions, afternoon sessions or full days. A full day will count as two sessions.
- **Childcare Vouchers:** We are registered to receive payment by child-care vouchers and from tax-free childcare accounts. Please contact the Bursary for further details.
- **Wrap Around Care:** Supervision from 8am-8.20am and from 3.30pm-4pm is free of charge.
- **After School Care:** The first session runs until 5.00pm and is charged at £8. The second session runs from 5.00pm-6.00pm and is charged at £12.00 as it includes tea. Charges apply for a session or part thereof. Early Birds Breakfast is on offer in Pre-Prep at a cost of £8.
- **WCC Free Entitlement to 15 Hours:** All parents of children aged 3 or more are entitled to 15 free hours of childcare for 33 weeks per annum under the Early Education Funding Entitlement. The 15 free hours are available daily from 8.15am to 11.15am. Parents wishing to take up their funded entitlement only should contact the Admissions department for availability as there are a limited number of such places available.
- **Enhanced Provision:** There will be a daily short session of a focused, taught activity each morning, such as Rhythm Time, Create Club, Sports Stars, STEAM and Outdoor Learning. The sessions are optional and their daily cost is included in the full session price above.
- **Due Payment Dates:** Fees are due in full by the first day of term unless paid under a direct debit. The School reserves the right to charge interest on overdue accounts at 2% over the school's bank's base rate.

- **Notice for Change:** A full term's fees are due if a child is withdrawn or sessions reduced without a full term's notice, in writing, to the Headmaster.
- **Term Lengths:** typical term lengths are based on 33 weeks a year split into three terms.
- **Terms and Conditions:** Please see the School's Terms and Conditions for further information about the payment of fees and extras. Copies are available on request from the Bursary. Please note in particular that a full term's fees are due if a student is withdrawn without a full term's notice, in writing, to the Head.
- **VAT:** Please note that there is a realistic likelihood of VAT being applied to fees charged by the School in the coming months or years. When such fees are applied, the School expects to revisit the fee sheet to ensure that charges reflect any savings including those on VAT reclamation. Please also note that any VAT charged will be for the account of the parents.

Remissions

- **Siblings:** 5% discount on net termly fees for a third child at Rugby or Bilton Grange.
7.5% discount on net fees for fourth (and subsequent) child at Rugby or Bilton Grange.
